What training will teachers be able to access?	LJ will:	
 WJEC training courses will be held in February 15th in Bangor and 16th in Mold . Anglesey headteachers have recently decided to send two representatives (Mefys and Angharad) and then send RS teachers to support the GwE RS Support Group. CAMU (Anglesey) – member from each school attends to discuss. Anglesey INSETs will focus on GCSE courses. GCSE meeting in the morning and teachers will work in the afternoon. Mefys will attend morning meeting in Anglesey and join the Gwynedd teachers in the afternoon. October 31st. 6 October – Fflint meeting for RS teachers. Hope to arrange for Wrecsam and Denbigh. Lead Practioners will fund their attendance on WJEC courses form their GwE allocation. 	 contact Lynda Maddocks regarding likely content of WJEC training courses (February). contact TT regarding his independent training courses. What will be the focus of the RS GCSE GwE Group meetings?	Mefys will:	
 Meeting once a term. PM has stressed that it's not the Lead Practioners' responsibility to train but to co-ordinate and support. Meeting 1 (0.5 day) in each Hub. Likely that first meeting will be update, end of October (Gwynedd and Anglesey), November (Wrecsam and Fflint). Collating and sharing. Teachers will be asked to bring draft specification with them and their current GCSE file (access previous recources). Would like to circulate questionnaire, e.g. most likely religion (Islam and Judaism in G and A), share findings. Opportunity for teachers to 'pair up' to work together within their Hub. Schools likely to offer Catholic Christianity, e.g. one school in Wrecsam, Syr Richard Gwyn. Meeting 2 (1 day for 3 Hubs – early January), e.g. Glasdir/Venue Cymru/Conwy Business Centre. Meeting early next term – ask someone for an INSET? Before or after February WJEC training course. When we change specification – how will teachers assess, samples of questions. Possibly invite, Chris Owens (Barry Comprehensive) – has led on Judaism and Islam, present Spec B, co-author ' Human Experience and Life Issues'. Also teachers will welcome opportunity to liaise, share good practice, network. Workshops, e.g.guidance on planning, assessment, teaching strategies. Key note speeches? Facebook page – for RS Teachers North Wales Meeting 3 (1 day in each Hub – June 2017 – after A Level RS examination after 27th June) – an opportunity to share samples, materials, early efforts. All schools to share 'something' for the first hour, e.g. starter, revision sheet, lesson plan. Rest of the day to work together to develop an idea. Last hour to share their work, and raise further questions, agree on next steps. Would Welsh medium schools in NE want to join Welsh medium schools in NW?
